This is the annual report of the Parochial Church Council (PCC) of St. Barnabas' Church, Clapham Common for 2019. It was collectively written and contains a review of the year, the statement on the responsibilities of the PCC, a treasurer's report, the description of the accounting policies and the independent examiner's report on the church accounts.

VICAR'S INTRODUCTION

Even though our wonderful Carol Service with string quartet was less than a year ago – in fact it was only last Christmas! – everything about 2019 feels somewhat remote. FINANCE REPORT

In 2019, St Barnabas continued to offer the congregation a wide range of worship opportunities whilst staying on budget. Huge thanks to all donors for making this happen through your reliable tithing and on-going generosity; it's so encouraging to be blessed in this way and we continue to appreciate your support and involvement for the transformative work we do here in church.

Our total income was £160,000 (of which £12K was designated income and not available as General Funds) with outgoings at £158,000. This represents excellent value given we have expanded our staff team with the addition of a Children & Youth Minister and continue the upward trend towards self-financing with our Parish Support Fund Pledge to Southwark Diocese. In 2019, we contributed £69,000 with £71,000 pledged for 2020.

Lettings capacity was at maximum in 2019 and we will see a drop in income from this previously dependable source in 2020 due to Covid 19 restrictions.

Thanks to the fundraising efforts of the Matthews family we raised nearly £2000 for the Stonework fund

OPERATIONS' REPORT

'Bustling with life' would be the best way to describe the year of 2019 in St Barnabas.

Our regular worship was complemented with many special services, including the Maundy Thursday evening Communion, Remembrance Sunday, Lessons & Carols and the Christmas Nativity Service. 11 children were also baptised and 3 couples married in St Barnabas.

Music was also very present. Sarah Hughes, our Director of Music, put together a series of Summer and Christmas concerts which were attended both by members of the church and members of our Community. Bolingbroke Academy also hosted their summer and winter concerts with c. 100 students accompanied by teachers and families.

Throughout the winter months, the Church was home to c. 40 guests, who were able to eat a cooked

on the tower.

An extra thank you to our Gift Aid donors as we reclaimed £12,000 in tax rebate from HMRC; taxpayers please sign a form if you haven't as yet as we're allowed to back date on the past four years donations.

Our invested reserves remain with CCLA at £55,500. Late in 2019, at the Diocese's prompting, the PCC agreed to realise a historic endowment of £3,000 plus interest and this will be reflected in the 2020 accounts.

It has been the policy that 5% of our unrestricted donations goes to Mission Giving so £3,350 of income from 2019 is pledged for our 2020 partners. We also carry forward an undisbursed liability of £1,495 from 2018.

dinner, sleep in a safe and warm venue and leave in the morning after breakfast.

St Barnabas was also home to our Barney's toddler group which welcome c. 30 families, to our Bible Study Group and to our Thursday Fellowship group.

The Ascension Hall has hosted Deanery evenings and Battersea Welcome Refugees' meetings.

This was made possible through the commercial letting of our venues to regular groups, as varied as a ballet school, a karate group, music classes and many more. The income from these lettings also enabled us to let venues to support groups, notably Alcoholic Anonymous, at a reduced rate.

So, St Barnabas was open! And even if the rhythm is different this year, St Barnabas is still bustling with life.

2019 Annual Report

FABRICS' REPORT

2019 was thankfully a quieter year for the Fabrics committee. Roof and gutters were fixed, rotting wooden lintels around doors were replaced but otherwise it was without large ticket items.

This was especially the case after years of extensive upgrade works within the church with new wooden floors, replacing lights with LEDs, reconfiguration of the choir vestry as well as the new kitchen to help our work (in normal times) with the Glasdoor homeless charity.

Our upgrade work is not yet finished and our key priorities remain as follows...as and when funds allow:

- (1) remedial work to the car park which often resembles a swimming pool;
- (2) Extensive works to the main entrance replacing the very old, damaged wooden doors with new glass doors. This will not only make the church more inviting from the outside but also improve security for groups using the church;
- (3) replacing the toilets.

PASTORAL OFFICES

In 2019, there were 11 baptisms, 3 weddings and 6 funerals. There was 1 confirmation and 3 children were admitted to Holy Communion on Easter Day.

PAROCHIAL CHURCH COUNCIL

The PCC trustees share responsibility for promoting the whole mission of the Church, its financial accountability, safeguarding users, the maintenance, preservation and insurance of the fabric of the Grade II listed building. They met 9 times in 2019.

BATTERSEA DEANERY SYNOD

The Battersea Deanery Synod met 3 times in 2019: there was *A Conversation with Marsha de Cordova, MP for Battersea* in February, *A Deanery Garden Party with guest speaker, Peter Graystone* in June and *The Possibility of Light: an artist's journey from Iraq to Syria with Arabella Dorman* in November. Meetings are more often than not open meetings meaning any interested non Synod members can attend on a one-off basis too.

ELECTORAL ROLL

A new roll was prepared in 2019. There were 102 members.

SAFEGUARDING

St Barnabas adheres to the Diocesan guidance *A Safe Church* when it comes to protecting vulnerable groups within the church environment. Using the Diocesan Annual Safeguarding Review, the Vicar, churchwardens and parish safeguarding officers (Sarita Rampat and Sandrine Simmons) systematically check procedures and then the PCC as a whole re-affirms its commitment to safeguarding children, vulnerable adults and those at risk of domestic abuse.

Measures include carrying out DBS checks on groups' leaders, pastoral team member and ensuring hirers agree to observe the church's safeguarding policies. Policies of our practice and for responding to concerns and can be found on the Safeguarding notice board in the Claris Hall and copies of the manual are available for reference at the back of the worship area, in the office, and online from our website and the Diocesan website.

The church is located on the north side of Clapham Common at the corner of Lavender Gardens.
